All Vendor spaces will be assigned on a first come first serve basis. We highly encourage all of our Vendors to be conscientious of the waste reduction by providing biodegradable/recyclable food container options.

**You are personally responsible for your Food Safe application. Food Safe applications submitted after July 6 are subject to a \$30 processing fee from Vancouver Coastal Health.**

- Food Truck - \$175; includes two free Festival passes per day
- Artisan Tent - \$125; includes one free Festival pass per day

- Festival starts promptly at 11am on Saturday, July 21, 2018; Vendors must remain open until the last act of the Festival (approx. 10 pm).
- Vehicles are not permitted on the Festival Grounds; except for set-up and take-down.
- Food and beverages served using recyclable or compostable plates, bowls, cutlery, and cups is highly encouraged. Absolutely NO Styrofoam!
- No disposable individual condiment packages, stir sticks, plastic straws, etc.
- The Festival Grounds are non-smoking and alcohol-free.
- We recommend including a large sign identifying your business name.
